In terms of the above-referred provisions of SEBI LODR read with the Master Circular no. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 ("SEBI Circular") and our letters dated October 18, 2023, January 30, 2024 and January 10, 2025 pertaining to Jaipur Stamp Duty matter, we wish to inform that the Company has filed a Writ Petition against the State of Rajasthan before the Hon'ble Rajasthan High Court, challenging the calculation/levy of stamp duty on its property in Rajasthan, which is likely to be listed for hearing on Tuesday, April 08, 2025.
