**Subject: Disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) – Update**

Dear Sir / Ma’am,

In reference to our earlier communication dated October 16, 2025, intimating receipt of order under Section 74 of State Goods and Services Tax Act, 2017 from The Joint Commissioner, CGST & Central Excise Bhopal demanding tax liability of Rs. 16,22,32,387/- along with penalty due to alleged excess availment of Input Tax Credit and short payment of outward tax pertaining to the Financial Years 2018–19 to 2022–23.

We wish to inform you that the Company had filed writ petition challenging the said order before the High Court of Madhya Pradesh at Jabalpur.

The said writ petition was listed for hearing on January 07, 2026 before the Hon’ble High Court of Madhya Pradesh at Jabalpur (“Hon’ble High Court”). The Hon’ble High Court after hearing the matter, has ordered that subject to deposit of 10% of the tax demand, no coercive action be taken against the Company. Please note that the Company is in process of depositing the same. The copy of the High Court order dated January 07, 2026 was received by the Company on January 08, 2026, at 02:10 P.M.

In terms of SEBI Master Circular SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 as amended read with Regulation 30 of SEBI Listing Regulations and SEBI Circular No. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2025/25 dated February 25, 2025, the information required to be disclosed to the stock exchanges is given under the **Annexure – 1**.
